Description of this fund

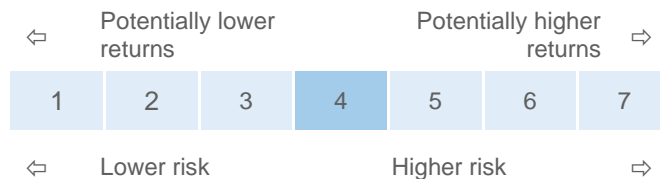
Objective: to perform broadly in line with the return of its investment benchmark before fees and tax over the long-term.

Strategy: aims for mid-range long-run returns by investing in a diversified portfolio with a balance of income and growth assets.

What are the risks of investing?

Risk indicator for the Hunter Balanced Fund¹.



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

Example of how this applies to an investor³

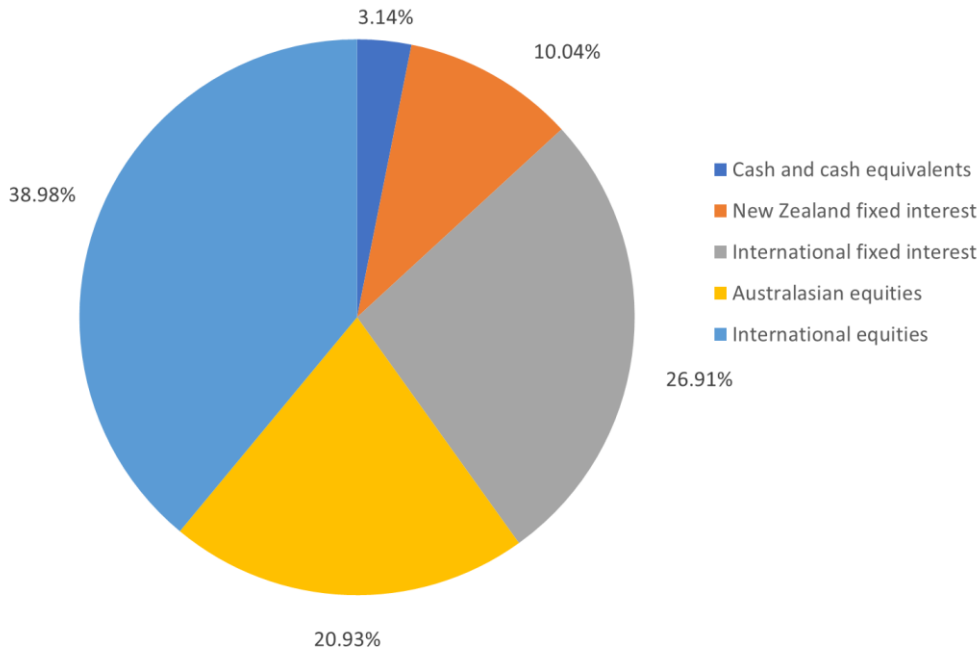
Small differences in fees and charges can have a big impact on your investment over the long term.

Anthony had \$10,000 in the fund when the fund received its first contribution, on 2 September 2020, and did not make any further contributions. At the end of the period to 31 March 2021, Anthony received a return after fund charges were deducted of \$457 (that is 4.57% of his initial \$10,000). This gives Anthony a total return after tax of \$425 for the year.

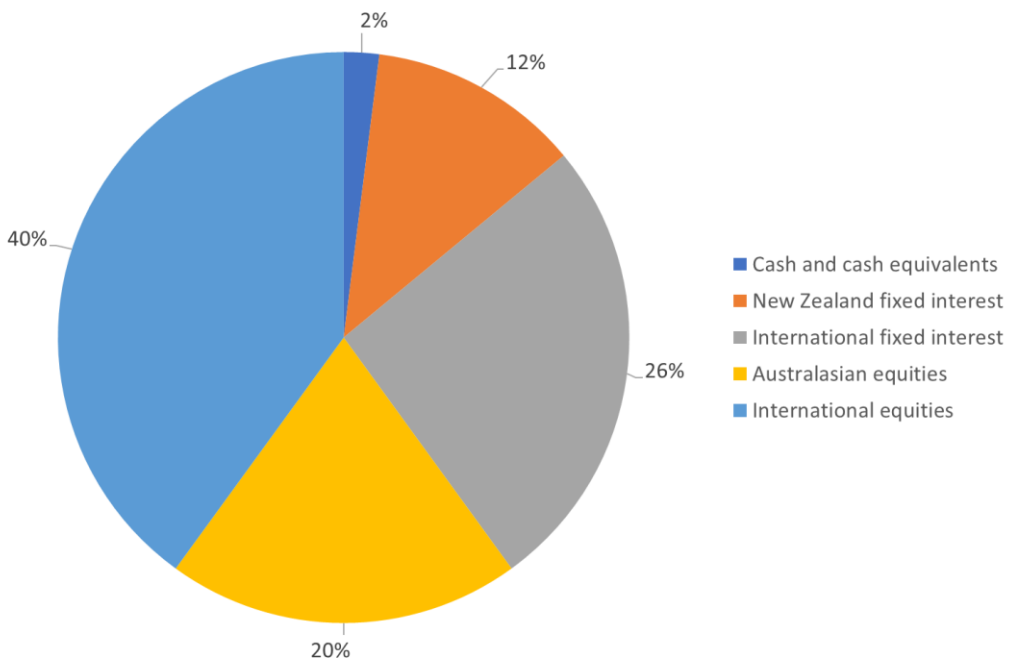
What does the fund invest in?

Notes

¹ A combination of actual fund returns and market index returns have been used to determine the risk indicator as the fund has not been operating for the required five years. The risk indicator may therefore provide a less reliable indicator of the fund's future volatility. Market index returns have been used until 2 September 2020 and fund returns thereafter.

² As the fund only started accepting contributions on 2 September 2020, historical fee information is not available.

³ As the fund has not existed for a full year, figures in this example are based on returns from the date of the first fund contribution (2 September 2020).
